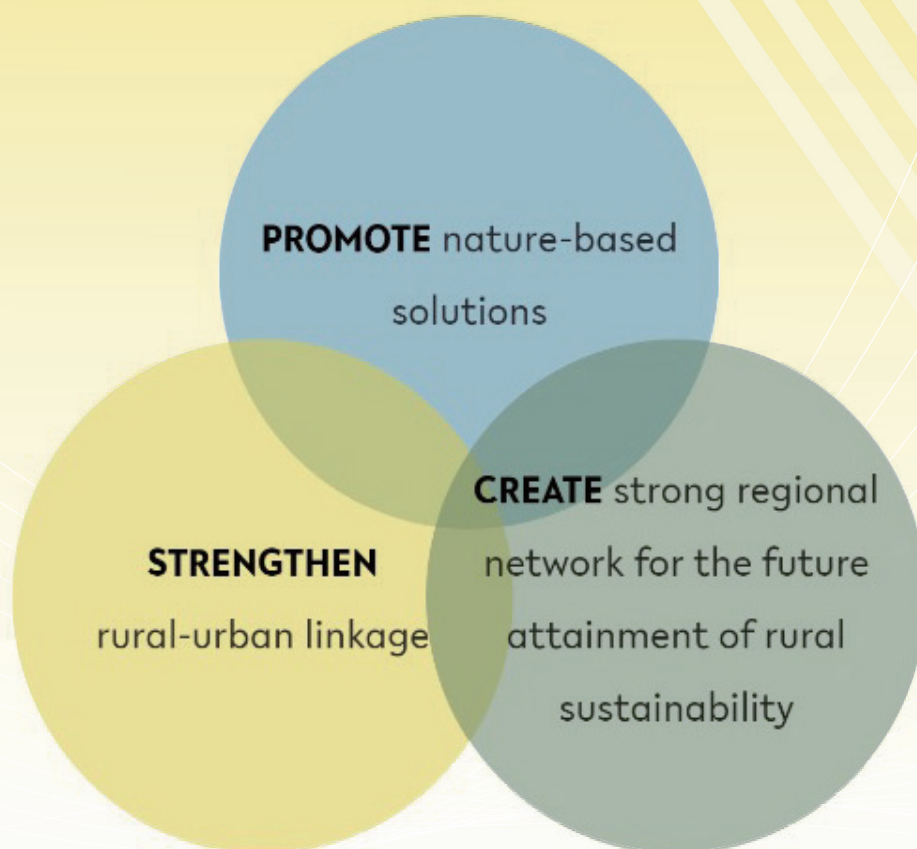

Introduction to the Fellowship



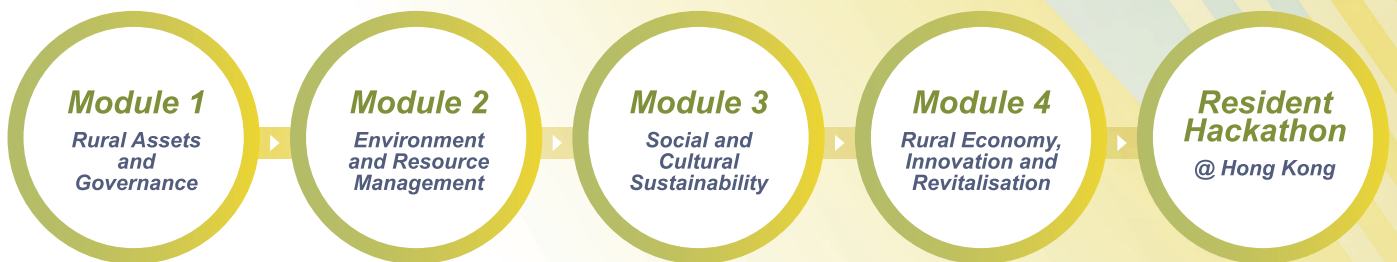
Urban-Rural Sustainability Fellowship 2022-23 is a core part of AIRI jointly organised by The University of Hong Kong, Tsinghua University, National Chengchi University, and Asian Institute of Technology. The one-year incubation programme aims to empower and connect thought leaders and exceptional practitioners from across the Asia-Pacific region who aspire to be change fellows spearheading urban-rural integration and rural sustainability.

The incubation programme includes a series of online master lectures, web-based practical training sessions, fieldtrips as well as an experiential Hackathon delivered by renowned international scholars and experts in the fields of rural governance and economy, conservation and resource management, social innovation and community revitalisation.

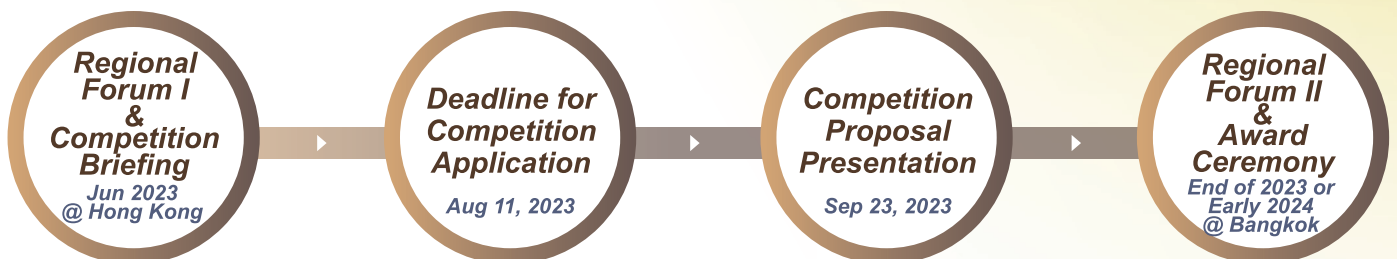
Fellows and Associate Fellows who have successfully completed the programme will earn a Certificate jointly issued by the four universities. Fellows will also be eligible to enter into a competition with innovative proposals that address rural sustainability challenges. There will be a total of four awards (one laureate from Mainland China, Taiwan, Hong Kong and Thailand, respectively), each with a seed grant of up to US\$25,000.

With the hope to pass on tribal cultural practice to the next generation, he organises a Tranan Aboriginal Culture Camp in Tranan tribe in Wulai, through practical operation and guided tours, to introduce the Atayal hunting knowledge.

Assignment Requirements

- Forming part of the Fellowship's completion requirement, each Fellow and Associate Fellow should submit a case study of the rural sustainability challenges and solutions in his/her country/region by **Jun 1, 2023**. The case studies submitted will be published on the AIRI website (<https://ccsg.hku.hk/airi/>) for knowledge exchange purpose in the region. Details of the case study format will be announced in due course.
- As part of the requirements to complete the Fellowship, each Fellow must submit an action proposal to address rural sustainability challenges in his/her country/region by **Jul 14, 2023**. Details will be announced in due course.

Competition

- Interested Fellows may apply for the AIRI Urban-Rural Sustainability Competition with an enhanced action proposal incorporating the comments and suggestions from peers and professors as well as relevant experts and locals.
- There will be a total of four awards for the competition (one laureate from

Mainland China, Taiwan, Hong Kong and Thailand respectively), each with a seed grant of up to US\$25,000.

Attendance Requirements

For Fellows

- Fellows should be committed to attending the Fellowship activities, including the online lectures, web-based practical training sessions, local field trips, the compulsory Resident Hackathon cum Regional Forum I in Hong Kong, and the compulsory Regional Forum II cum Competition Award Ceremony in Bangkok.
- Fellows who attained an attendance rate of not less than 90% and fulfilled the assignment requirements will be awarded a Certificate of Achievement issued jointly by The University of Hong Kong, Tsinghua University, National Chengchi University, and Asian Institute of Technology.
- Fellows who have met the attendance and assignment requirements will be eligible to enter into the AIRI competition with innovative proposals that address rural sustainability challenges.

For Associate Fellows

- Associate Fellows may participate in the Fellowship's online lectures, web-based practical training sessions, and local field trips (whereas the resident hackathon in Hong Kong and the competition proposal submission are open to Fellows only).
- Associate Fellows who attained an attendance rate of not less than 70% and fulfilled the assignment requirements will be awarded a Certificate of Attendance issued jointly by The University of Hong Kong, Tsinghua University, National Chengchi University, and Asian Institute of Technology.
